F. Identity Verification and Statement of Educational Purpose

As per federal regulation, Immaculata must receive documentation of your identity AND a signed Statement of Educational purpose for the 2019-2020 award year.

Submit a copy of government-issued photo identification (such as a driver's license, passport, or military ID); **AND**

Submit a Statement of Educational Purpose signed by the student and parent for the 2019-2020 award year.
